## **Parishioners Question Time**

- 1 Apologies: Mr Boorman due to work commitments, Councillor Thornton
- 2 The minutes of the last meetings were amended, January minutes were amended to include under Councillors present changed from Mr Talbot to Mrs Talbot and under the heading Seal Over 60's Mrs Talbot proposed the motion and this was agreed by the Council and signed.

In November minutes there was an amendment in the Election for Underriver Ward, Mrs Talbot said that she resigned from Seal Ward and elected into Underriver Ward and this was agreed.

#### 3 Declarations of Interest - None

#### 4 Clerk's report was circulated.

MDH Horticultural Contractors have been instructed to cut the wildflower verges this month. The clerk has noticed that some of the signs are still down and would require a Councillor Representative to put them back in the ground. So that it helps KCC contractors to know where to cut and areas not to cut.

The Caretaker has agreed to do the checklist for the play equipment on a weekly basis. Mr Bourne has mentioned that for one month this may not be feasible due to personal reasons but a Councillor Representative could volunteer on his behalf.

MDH Horticultural Contractors have increased RPI to 8% which is still within our agreed budget for the year 2023/24.

British Gas who supply electricity for Seal Pavilion their contract will run out soon, and as per our financial regulations we have managed to secure a contract for 3 years with Scottish Power which is within the budget for 2023/24.

# Details of consultations open:

Consultation opens on KCC's Home to School Transport Policy

Having attended the Clerk's SDC Forum, it was mentioned that West Kent authorities hope to fund a Rural Support Officer to aid delivery for UK Shared Prosperity Fund. Funding

from 2022-2025, this will be for investment priorities for Community and Place, supporting businesses and people skills.

Mrs Talbot raised about the key safe in Seal Pavilion and the clerk advised that she hasn't received any further details or communication from councillors.

# 5 KCC Matters – Councillor Gough's was not present at the last meeting but reported updates to the Council after the meeting which was shared to Councillors.

- Childsbridge Lane KCC have received confirmation of invoice to proceed with the works which won't be implemented until the new financial year.
- **Zion Street road markings**, following resurfacing, if the markings were burnt off it would damage the road and not worth the cost therefore no action to be taken.
- **Godden Green Pond** KCC to provide a quote for dredging the pond and taking away 8-10 tons bags. There was discussion that it is bird nesting season between 1 March until September and no work could be done.
- **A25 SID column** The Parish Council will vote on the cost of the new pole and ask further on a survey.
- **A25 speed limit** Mr Haslam attended the December Sevenoaks JTB where the speed limit was approved.
- Seal Highway Improvement Plan A meeting was organised between the Highways
  Working group and KCC to discuss priorities on the HIP. KCC have a new template
  which information has been transferred, they looked at observations for Carters Hill
  cycling issue, Childsbridge Lane speed reduction, and A25 speed reduction which is due
  to go ahead. KCC will try and help with the Highway budget.
- Sevenoaks Urban Area Local Cycling and Walking Infrastructure Plan (LCWIP) Route 6 which passes through Childsbridge Lane and Seal Recreation Ground, the Parish Council to focus on the impact on the pedestrian, walking bus and cyclist. Action SPC to review and discuss whether a letter needs to be sent to SDC.
- **Disabled Parking Bay** KCC would take a view once PC have made a decision.
- Consultation of the Home to School Travel Policy -
- The bus company model is still being reviewed, the consultation isn't effecting Seal Parish directly. It was confirmed that whilst millions are spent on school travel. In regards to costs there was a significant over spend in 22/23 due to inflation and other overall costs being higher than was budgeted, these costs are expected to remain high for 23/24.
- **Community Services Consultation** Seal library is not effected in the consultation, but KCC may look at other libraries in the future and community assets.

It was mentioned that the road closures are misleading on side roads, more information is required, people are ignoring the signs. Most road closures are for gas, water, electricity and power are limited to statutory undertakers. There needs to be more planning on closures especially emergency works. Councillor Hogarth mentioned that the convenience store has been cleared by SDC Clean up Team but there is still more work involved. Seal Primary School had an internet safety day at Stag Theatre and was given advice on the internet.

## 6 Other Matters Requiring Discussion and Action

#### **6.1 Street Naming Consultation**

The Parish Council are being consulted on a new road name for the forthcoming extra care housing scheme at the Wildernesse House Site. The new road will form the access to the

five blocks of flats from Park Lane. The developer has suggested Wellington Rise as a new road. Our local historian had produced some street names which could be suggested to SDC. These were Violet Mills, Carriage Drive or Swift, as one of our Councillors recently deceased we could suggest Watson Rise as an alternative. Mrs Talbot proposed that we suggest Carriage Drive and Watson Rise and this was seconded by Mr Michaelides and agreed unanimously.

# 6.2 Seal Village Hall

Seal Village Hall Committee would like to put in an application for funding of three new noticeboards for the village hall these will be located on the High St, to improve communications to residents. A grant for £2,473.50 (inclusive of VAT) has been requested. It was suggested that they could fund themselves. There was an adhoc request for the Parish Council to consider a policy on giving grants. Mr Michaelides proposed to fund half of the costs up to £1,500 and this was seconded by Mr Martin and agreed unanimously.

#### 6.3 SID A25

The council to discuss and vote on accepting the quotation for £851.85, from KCC for replacing the pole on the A25 adjacent to Park Lane with a galvanised steel pole, suitable for carrying the Parish's SID unit. We will have to remove the east facing bracket on the western post so that we have 6 sites, Mr Bourne proposed £851.85 to replace the existing pole on A25 and this was seconded by Mr Martin and agreed unanimously.

There were toad signs on the SID post which was noted to KCC. Toad signs cannot be placed on SID posts so therefore there will be a new pole coming which KCC have paid for.

### 6.4 KALC Sevenoaks

Mr Haslam attended the KALC AGM on 27<sup>th</sup> January and reported that they are struggling to fill roles at the meeting and nominating people on the JTB. Our Chairman (Mr Haslam) is a non-member of JTB and will build a rapport for management team for highways. There are meetings third Friday in March, June, September and December.

#### 6.5 HIP

Councillors attended KCC meeting to discuss the HIP. There are two areas that we are going to review in our HIP plan these are:

Signage for Carters Hill (Cyclist)

Red Lane junction due to accidents. Once these two points have been reviewed along with our overall HIP plan, the Council will propose the changes at a future meeting.

ACTION: Mrs Talbot to provide and share the updated HIP.

## 6.6 Clerk Training

The Clerk has asked if it would be possible for SPC to cover the additional hours for her attendance of courses/training (as per her appraisal)

The first two courses are HR Summit and Social Isolation and Loneliness from the Local Council perspective. The total hours would be 7 hours. The Chairman and staff committee are considering the request and will check the TOR that is required, clerk to provide to the Council to review and act accordingly.

# 6.7 Replacement SPC Laptop

The current 14-year-old SPC laptop is no longer fit for purpose and needs to be replaced.

- 1. The Council to agree a working party to discuss and agree the final spec and device. There was a discussion on the old computer and old disk drives which wouldn't be compatible with the new projector, and whether we should have a group of people to discuss windows or apple going forward, we don't need high spec, useability you pay higher price or lower price. It's a choice between windows or apple.
- 2. The Council to approve to purchase a new SPC Laptop up to a maximum price of £1200 (incl VAT). For the time-being we will postpone for 2 months.
- 3 The Council to agree to form a working party to evaluate a replacement SPC email system. This wasn't discussed at the meeting.

#### 6.8 Seal Pavilion

The clerk mentioned that in the main hall the heater requires replacing and we might want to quote for new heaters in the changing room end as they are old. Our Electrical inspection is due this year and it would be worth getting quotes.

The Parish Council to discuss the Grass Maintenance Fund which has been circulated to Councillors, given that the survey from the club has been completed, the Parish Council require to discuss or find out further on the Licence that is required.
