#### **Parishioners Question Time**

2 parishioners and one member of public attended the meeting, one of the parishioners expressed despair due to her situation that she didn't meet the criteria for housing in Foxbury Farm. She had a strong link to the hamlet and her family had lived in the village for over 20 years. Councillor Thornton said that SDC had completed the process fairly and there only must be a link to the Parish to be considered for the housing allocation. But Councillor Thornton had been lobbying for this parishioner and her family and has offered to help her, with her situation.

- 5 KCC Matters Councillor Gough's was not present at the meeting but will send a report to be shared at the next meeting.
  - Godden Green Pond A quote has been received from a contractor used in 2019 and are awaiting further from KCC whether quote has been accepted.
  - Wildflower verges The PC are still awaiting a quotation for KCC to cut verges and a quote for seeds.
  - We have received the invoice for the KCC Highways work for the speed reduction on Childsbridge Lane, the Council has already approved the expenditure and won't apply for CIL funding and will write and send the cheque in the next few days in order not to delay the work being done.
- 6 Other Matters Requiring Discussion and Action

#### **6.1 HIP**

Mrs Talbot proposed to accept the HIP as it stands as a working document and authorise the Highways working group to continue discussions with KCC Highways and report back with proposals and costings and this was seconded by Mr Martin and agreed unanimously.

# 6.2 Civility and Respect

The Chairman noted that the Council had not had time to see the certificate and would like to defer to the staff committee regarding the training programme for Councillors and Staff.

But is happy to sign the Civility and Respect Pledge as long as the Council are in agreement and will report back at the next meeting in April. The Certificate states as below:

- Treat all councillors, clerk and all employees, members of the public, representatives of partner organisations and volunteers with civility and respect in their role.
- Put in place a training programme for councillors and staff.
- Sign up to Code of Conduct for councillors.
- Have in place good governance arrangements in place including, staff contracts, and Dignity at Work Policy.
- Commit to seek professional help at early stages should civility and respect issues
- Commit to calling out bullying and harassment when if and when it happens.
- Continue to learn from best practice in the sector and aspire to being a role model / champion council e.g., via Local Council Award Scheme.
- Support the continued lobbying for the change in legislation to support the Civility and Respect Pledge including sanctions for elected members where appropriate.

#### 6.3 Staff Committee

Mrs. Talbot proposes that the Staffing Committee Terms of Reference is adopted by the Council and this was seconded by Mr Michaelides and agreed unanimously.

# 6.4 Sevenoaks Volunteer Transport Group

Mrs Talbot proposes that the Council grant £250 and this was seconded by Mr Michaelides and agreed unanimously.

#### 6.5 South East Water

Due to the issues experienced with the supply of water in the summer months and loss of water in our Parish, South East Water have given a grant from their community chest to the Parish Council of £2,500 to use within our community, there were discussions around whether the grant could be used for community projects within our Parish.

# 6.6 Seal Recreation Playground

As discussed in the February meeting a volunteer is required in the short term to carry out inspections for the play equipment at Bitchet Green. The clerk will ask our Caretaker or seek additional volunteers from the community.

#### 6.7 CIL Contributions

The Council were not considering using CIL funds for the reduction of speed limit along Childsbridge Lane but if projects arise from the HIP this may be considered and agreed by the Council.
